An apology from the Editor

My apologies for errors that crept into the last issue especially my naming of Somerset Walking Group as 'West Somerset Walking Group'

Who Owns Public Paths ?

Many people, including some Ramblers, assume we walk public paths and bridleways with the kind consent of the landowner. This is not the case as you have the same right to walk them as you have to drive your car on a public road. While the landowners interests and needs should be taken into account the right to use recorded Rights of Way is absolute unless a legal, usually temporary, closure by the Highway Authority is in place.

If many people, including many path users, believe that public paths belong to the landholders whose land they pass over are they right? The National Farmers' Union, the Country Landowners' Association, and the Countryside Commission, in an early edition of their booklet "Managing Public Access" said: "In simple terms, the surface of a highway, whether a public right of way or a road, is owned by the Highway Authority rather than the owner of the land over which it passes."

If local 'landowners' understood that they do not, in the majority of circumstances, own the surface of the paths, or at least that any ownership is subservient to the Highway Authority's ownership, then they might not feel such a sense of personal possession of these little public highways. They could then treat them more like they treat the public roads which cross their holdings, and be less concerned at public use and less likely to try to move or to disturb these little ways.

If Highway Authority officers fully understood that the paths are their official property then that would help to direct their actions when for example local 'landowners' plough up their paths or obstruct them. Indeed in certain cases the Path Officers can act at once under common law as owners of the paths without waiting for the sometimes tediously lengthy and time consuming statutory processes.

While we accept that changes need to be made from time to time to the RoW network, Ramblers view is that RoW are historic routes and they should only be altered for good reason and we should have the opportunity to consider any changes before they proceed.

This is one of the key jobs that our hardworking footpath secretaries undertake on your behalf.

MENDIP RAMBLERS' AUGUST BANK HOLIDAY FREE WALKING FESTIVAL: 24/25/26 August 2019

This year's festival is based in **Shepton Mallet**, the Somerset town noted now mainly for its cider making, but with a long history. There are Neolithic and Iron Age remains and Bronze Age burial sites nearby. The town sits just off the Fosse Way: the old Roman Road and evidence of Roman settlements can still be seen. Shepton features in the Domesday record as Sceptun meaning sheep farm with the second part of its name deriving from the French Malet family who acquired the land after the Norman Conquest. There are Norman effigies in the Church of St Peter & St Paul.

For many years it was a prosperous market town whose wealth came from the woollen trade. Now, as well as the cider, it offers excellent walking opportunities for all.

The Walking There will be 4 walks each day. The short morning walks (3/4 miles) can be extended after lunch with the short afternoon walks of similar length. The medium walks will be 7 miles and the long walks 11 miles. We hope that the availability of two short walks will encourage walkers of all abilities to join us. Children with their families are especially welcome. Morning walks start at 10.00am and the afternoon walk at 1.30pm.

As usual, tea and cake will be available at the end of each walk.

Area Footpath Secretary's Report

- 1. Claim for path at Blue Anchor** – West Somerset, applied to the Secretary of State to require the County Council to process the application. The Secretary of State agreed our request and the County must now deal with the application this year.
- 2. Changes to the definitive map** – we continue to receive consultations on changes to RoW which are sent to the relevant Group FPS for consideration. This provides the opportunity, if we do not object to the proposal outright (which may result in the application being withdrawn), to suggest alternatives which the highway authority can put to the applicant.

3. **Cropping of Paths** – If a cross-field Right of Way is found to be cropped it is important to report it to the Highway Authority (Somerset County or North Somerset). See page 2
4. **A303/A358 Dualling** – we have been consulted over the detailed route of the section between Sparkford and Podimore and been able to agree safe alterations to the RoWs. The detailed proposal for the widening of the A358 has been delayed.
5. **Long Standing Obstructions** – Little action appears to have taken place on the key obstructions that we have identified to SCC. I would welcome suggestions on how we could proceed. The routes identified are seen as key in the network.
6. **SCC Classification of RoW** – The County Council has contacted all Parish Councils to ask them to check the classification of all RoWs in their Parish. The CC previously classified all RoWs about 10 years ago and wants to up-date these. The Area Chair has tried to ensure that Ramblers point of view on the classification is also taken into account. The tendency is to downgrade them wherever possible to avoid maintenance costs.
